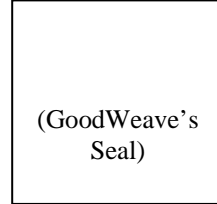

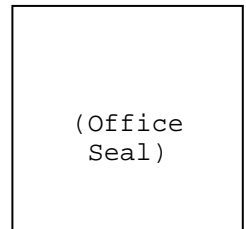

### Criteria for General Membership - Carpet Sector

- 1) The firm is a GoodWeave Licensee and it hereby repeat its unequivocal commitment to the complete removal of child labour in all activities of our carpet factories and that of its suppliers and to abide by all other terms and conditions of the Licence Agreement. GoodWeave's inspection monitoring report will be considered as a basis.
- 2) The firm, as a General Member of GoodWeave shall uphold the ideals and objectives of NRF towards promoting a socially and environmentally responsible business practices.
- 3) The firm is duly registered with the concerned authorities, the registration is renewed and it submits the income tax certificate.
- 4) The firm's Board has decided to be a General Member of Nepal GoodWeave Foundation.
- 5) The firm accepts the Constitution of GoodWeave and is ready to pay the required Fees once the Membership is accepted.
- 6) The firm is a Licensee of GoodWeave for over a year and has already labelled at least 500 square metres of its carpet with GoodWeave.
- Or, the firm has been a Licensee of GoodWeave for more than 3 years
- 7) The firm understands that for whatsoever reason, Executive Committee of GoodWeave has the right to reject the firm's Application for Membership.
